

# Fees for 2008 (Minor-Aged College Students)

<b>Homestay Placement (Per Occurrence)</b>	<b>\$250<sup>00</sup> CDN</b>
Based on each individual's pre-determined needs, Canadian host families are carefully interviewed and screened for suitability. All initial placements include a 30-day guarantee. If you are not satisfied with your homestay a 2 <sup>nd</sup> placement is arranged at no charge.	
<b>Basic Homestay Accommodation Options</b>	
Basic homestay accommodation includes a private bedroom with closet and student desk; the use of telephone (long distance charges not included); and the use of in-house laundry facilities.	
• <b>Full Board Accommodation (Weekly)</b>	<b>\$187<sup>50</sup> CDN</b>
All three meals are available for the student on a daily basis (breakfast, lunch and dinner).	
• <b>Half Board Accommodation (Weekly)</b>	<b>\$175<sup>00</sup> CDN</b>
Only two meals are available for the student on a daily basis (breakfast and dinner).	
<b>Premium Homestay Enhancement Options</b>	
Three homestay enhancement options can enhance the homestay experience. Premium homestay enhancements are subject to availability during peak seasons:	
• <b>High Speed Internet Access (Weekly)</b>	<b>\$8<sup>75</sup> CDN</b>
High speed internet access. Students must supply own laptop or personal computer.	
• <b>Proximity to School (Weekly)</b>	<b>\$12<sup>50</sup> CDN</b>
Homestay residence is conveniently located within the same transit zone as the school.	
• <b>Private Bathroom (Weekly)</b>	<b>\$25<sup>00</sup> CDN</b>
Exclusive use of personal bathroom facilities, including shower or bath.	
<b>Monitored Custodial Guardianship Option</b>	
FCI is pleased to provide a custodial guardianship and monitoring service for unaccompanied students under the age of majority in Canada.	
• <b>Custodial Monitoring (Per 4-Month Term)</b>	<b>\$85<sup>00</sup> CDN</b>
Liaising between the school, host family, and agent/parent, FCI conducts regular site visits and provides quarterly written reports highlighting the progress of the student.	
• <b>Custodial Guardianship Setup Fee (Per Occurrence)</b>	<b>\$150<sup>00</sup> CDN</b>
Preparation of notarized documentation outlining the role of FCI as a Custodial Guardian for a minor aged student.	
<b>Medical Insurance Coverage Option (Weekly)</b>	<b>\$15<sup>00</sup> CDN</b>
Students should have adequate medical coverage while studying in Canada. While several insurance companies may be available our medical coverage is provided by reputable insurers in Canada.	
<b>Airport Transportation Options</b>	
Door to door chauffeured transportation by drivers who are professionally licensed and insured.	
• <b>One-Way Transportation (Per Occurrence)</b>	<b>\$85<sup>00</sup> CDN</b>
Transportation directly from the airport to the homestay <u>OR</u> from the homestay residence to the airport.	
• <b>Two-Way Transportation (Per Occurrence)</b>	<b>\$160<sup>00</sup> CDN</b>
Transportation directly from the airport to the homestay <u>AND</u> from the homestay residence back to the airport.	
<b>Homestay Re-placement Option (Per Occurrence)</b>	<b>\$100<sup>00</sup> CDN</b>
Students wishing to change homestay accommodation following the 1st month will be charged a reduced placement fee.	
<b>International Banking Transfer Fee or Pre-authorized Payment Fee (Per Occurrence)</b>	<b>\$25<sup>00</sup> CDN</b>
